CORRIGENDUM

In regards to the Tender Notice No.RCN/Tender/649/2013-Vol-V Dtd. 26th October, 2017, serial No. 10 mentioned in the specification may be read as 15m x 20m instead of 80m x 80m and the last date for submission of tender has been extended upto 20th November, 2017 till 4:00 pm and opening date shall be on 21st November, 2017 at 2:30 pm, however other terms & conditions and specification remain the same.

Terms and Conditions:

1. Cost of Tender fee is Rs. 1000/- (Rupees one thousand) only **Non- refundable** to be deposited in favour of the Joint Director, ICAR Research Complex for N.E.H. Region, Nagaland Centre, Jharnapani, Medziphema by means of Demand Draft payable at S.B.I., Medziphema. **Non submission of the cost of Tender paper and Earnest Money shall lead to non – consideration of the Tender. Earnest Money should be deposited @ Rs. 2.5% of the quoted rate (refundable).**
2. Every quotation should consist of two Bids- The techno-commercial bid (**Bid 'I'**) and the Financial bid (**Bid 'II'**). Both must be submitted in two separate envelopes to be sealed **and put in a single main cover. The outer main cover should be super scribed as "CORRIGENDUM NO.RCN/Tender/649/2013/Vol-V dt:14.11.2017"** and addressed to "THE JOINT DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION, NAGALAND CENTRE, MEDZIPHEMA-797106". The Bidding firm should give their complete address on the bottom left corner of the Main Cover. **The Cost of the Tender as well as the consolidate Earnest Money along with all other Technical Details should be mandatory kept in the Technical Bid only. The Financial Bid should consist of the Rates, their detailed break -ups, etc. Non-compliance of this shall lead to non-consideration of the Bid.** All Tenders should be sent by Registered Post. Tenders to be handed/ delivered should be put in the Tender box, kept in the office chamber of P.A, ICAR Research Complex for NEH Region, Nagaland Centre, Medziphema-797106 not later than **04:00 P.M. on 20th November, 2017.** Tenders received after the due date and time shall not be considered under any circumstances.
3. **Price quoted must be all inclusive, including packing, forwarding, Delivery charges, Taxes, VAT etc., as may be applicable.**
4. On the date of opening, only Part-I (Technical Bid) will be opened. Part-II (Financial Bid) Shall be opened subsequently only of those tender, whose Technical Bid qualifies as per the laid norms of this tender.
5. The selected tenderers must complete the supply/ installation/ demonstration within 40(forty) days from the date of the supply.
6. Legal jurisdiction for all disputes shall be within the purview of the Dimapur Court.

7. All bidders shall give an undertaking that they fully and unconditionally agree to abide by all the terms and conditions which, if needed, may be modified at the discretion of the Competent Authority, in supply order, for which confirmation from the supplier shall be taken. **Non submission of the undertaking may lead to rejection/ non-consideration of the tender.**
8. The guarantee/ warrantee should be from the date of installation. All guarantee/ warranty services should be attended within a maximum limit of 15 days, failing which, proportionate deductions from the security deposit may be made at the discretion of the Institute.
9. The complete details regarding the Institutions/ Corporations/ Bodies, etc. where the Firm/ Dealer has made the supplies during the last 2/3 years should also be furnished, along with the supply orders.
10. **Items should be supplied in time with FOR destination and installation at Dimapur, Wokha, Longleng, Kiphire, Tuensang, Zunheboto, Kohima, Peren & Mokokchung. Test run should be done without any extra charges**
11. **All the bidders should quote their rate separately for their quoted items along with technical bid and financial bid.**
12. **The bid should submit the detail features & specifications of the Tender item submitted.**
13. **Last date and time of the receipt of tender is upto 4.00 PM of 20th November, 2017.**
14. Tenders shall be opened on 21st November, 2017 at 2:30 pm, ICAR Research Complex for NEH Region, Nagaland Centre, Medziphema, Nagaland-797106. Interested bidders may attend the opening.
15. **The Bidders should mandatory provide their full Bank Details, PAN Card No. , IFS code No., and TDS so as to ensure e-payment to them directly on satisfactory completion of the Supply/ installation with cum demonstration certificate should be submitted through the concern scientist/ In-charge and Joint Director to whom the supply is made (which should be free of cost and must be completed before payment).**
16. No payment will be made in advance.
17. Bill in triplicate to be submitted to the undersigned for arranging payment.
18. The Joint Director reserves the right to accept or reject any quotation without assigning any reason thereof.
